- Turn off your sprinkler system timers for the winter months
- If you haven't already, insulate your outdoor plumbing to keep your pipes from freezing and breaking
- Allow your grass to grow longer and apply mulch to landscaped areas to retain moisture

Also, if you hear any running water sounds inside, check your faucets for potential leaks and your toilets for wasteful draining or cycling.

- Our history dates to the late 1940s when developers Lusk and King established the Del Paso Manor neighborhood
- Many of our community street names are named after many of Mr. Lusk's family



- Many of our wells and pipelines were installed right after World War II during Harry S. Truman's presidency
- Over 20 percent of our water mains in the residential area were made from surplus war steel pipe
- Our first customer rate increase was in 1978 when our former Board of Directors voted to rely on customer water rates vs. county taxes to fund operations
- Since 1978, we have only had 12 customer water rate increases
