	Written plan for procedure and schedule for review and approval by Del Paso Manor Water District (DPMWD). Plan must include how water will be put to beneficial use.
	All valves and hydrants to be operated by DPMWD representative (unless otherwise approved).
	Testing schedule to be approved by DPMWD and performed during normal DPMWD operating hours and in the presence of a representative of DPMWD. A second DPMWD operator will also be on hand to monitor and make system demand changes to well(s) during testing period. Each DPMWD employee involved during testing will be billed to Applicant at *current rate of \$120.00 per man per hour. The minimum billing charge is four (4) man hours.
	Total of water used for testing to be determined by DPMWD at completion of (each) test. Water usage fees to be at *current rate of \$ per each hundred cubic feet (748 gallons).
	TERMS: Fees will be deducted from deposit and any balance will be billed and is due upon receipt of bill. Unpaid balance(s) may result in suspension of permits, stoppage of work or delay of project sign off.

GENERAL CONDITIONS AND REQUIREMENTS:

- 1. In the event that water conservation requirements change DPMWD may be required to cancel the testing.
- 2. Valves must be opened and closed SLOWLY using approved tools.
- 3. Permit holder shall, by acceptance and use of this permit, be responsible for any damages to fire hydrant(s), appurtenances and meter assembly as a result of the testing herein authorized, shall be held responsible for the cost of its repairs, and agrees to pay such costs as soon as the amount thereof is known.
- 4. The Permit holder shall defend, indemnify and hold DPMWD, its officers and employees, harmless from and against, all claims and/or liabilities for injury to person or persons, or damage to property arising out of the exercise of the permission herein given.
- 5. The Permit holder shall cease using water at any time upon request of DPMWD or its employees.
- 6. This Permit may be revoked at any time.
